12. Action Items

For Executive Committee Approval

Mental Health Block Grant (MHBG)

- DBHR contract for MHBG services in the region, the funding for the one-year contract cycle is **\$1,098,520** from July 1, 2017 through June 30, 2018.
- County Funding is allocated for housing support services and/or staffing to assist individuals in accessing housing resources and stabilizing their current housing situation.
- Compass Health funding is being used to augment school based services in San Juan County for children and families who do not qualify for Medicaid services.
- Tulalip Tribes funding is providing prevention and intervention services to at-risk youth.
- Indian Health Board will be working with the local Tribes conducting a feasibility study for the development and implementation of Behavioral Health Aides for mental health outreach.

Motion #17-49

- DSHS-DBHR-NORTH SOUND BHO-MHBG 17-18 for the purpose of funding MHBG projects throughout the region. The maximum consideration on this contract is **\$1,098,520** for the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO -ISLAND COUNTY-MHBG-17-18 for the purpose of providing housing support services in Island County. The maximum consideration on this agreement is **\$69,610** for the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO -COMPASS HEALTH SAN JUAN-MHBG-17-18 for the purpose of providing in school based services for non-Medicaid children/youth in San Juan County. The maximum consideration on this agreement is **\$37,963** for the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO -SKAGIT COUNTY-MHBG-17-18 for the purpose of providing peer support center services in Skagit County. The maximum consideration on this agreement is **\$96,899** for the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO -SNOHOMISH COUNTY-MHBG-17-18 for the purpose of providing peer support center services and permanent supportive housing support services in Snohomish County. The maximum consideration on this agreement is **\$600,861** for the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO -WHATCOM COUNTY-MHBG-17-18 for the purpose of providing housing support services in Whatcom County. The maximum consideration on this agreement is **\$168,339** for the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO -TULALIP TRIBES-MHBG-17-18 for the purpose of providing prevention and intervention services for at risk youth at Tulalip. The maximum consideration on this agreement is **\$74,849** for the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO -NW INDIAN HEALTH BOARD-MHBG-17-18 for the purpose of conducting a feasibility study for the development and implementation of Behavioral Health Aides. The maximum consideration on this agreement is **\$50,000** for the term of July 1, 2017 through June 30, 2018.

Substance Abuse Block Grant (SABG)

- DBHR contract for SABG services in the region, the anticipated funding for the one-year contract cycle is **\$2,972,513** from July 1, 2017 through June 30, 2018.
- Housing Support Services for pregnant, postpartum and parenting women are provided by Brigid Collins in Whatcom County, Catholic Community Services in Skagit County and Evergreen Recovery Services in Snohomish County.
- Opiate Outreach Services are provided by the counties, this service aims to engage individuals who use intravenous opiates into treatment.

Motion # 17-50

- DSHS-DBHR-NORTH SOUND BHO-SABG 17-18 for the purpose of funding SABG projects throughout the region. The maximum consideration on this contract is **\$2,972,513** for the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO-BRIGID COLLINS-SABG HOUSING-17-18 for the purpose of providing housing support to pregnant, postpartum and parenting women. The maximum consideration on this contract is **\$31,952** with the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO-CATHOLIC COMMUNITY SERVICES NW-SABG HOUSING-17-18 for the purpose of providing housing support to pregnant, postpartum and parenting women. The maximum consideration on this contract is **\$132,000** with the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO-EVERGREEN RECOVERY SERVICES-SABG HOUSING-17-18 for the purpose of providing housing support to pregnant, postpartum and parenting women. The maximum consideration on this contract is **\$54,326** with the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO-ISLAND COUNTY-SABG OUTREACH-17-18 for the purpose of providing funding to conduct opiate outreach. The maximum consideration on this contract is **\$86,251** with the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO-SKAGIT COUNTY-SABG OUTREACH-17-18 for the purpose of providing funding to conduct opiate outreach. The maximum consideration on this contract is **\$100,000** with the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO-SNOHOMISH COUNTY-SABG OUTREACH-17-18 for the purpose of providing funding to conduct opiate outreach. The maximum consideration on this contract is **\$120,000** with the term of July 1, 2017 through June 30, 2018.
- NORTH SOUND BHO-WHATCOM COUNTY-SABG OUTREACH-17-18 for the purpose of providing funding to conduct opiate outreach. The maximum consideration on this contract is **\$111,727** with the term of July 1, 2017 through June 30, 2018.

Medicaid (PIHP)

DBHR contract amendment for the period of July 1, 2017 through June 30, 2018. This is a Fee for Service contract with no maximum consideration.

Motion #17-51

- DSHS-DBHR-NORTH SOUND BHO-PIHP-16-18 Amendment 3 for the purpose of providing Medicaid funding to the region on a fee for service basis. The term of this contract is extended by 12 months, for a term of April 1, 2016 through June 30, 2018.

Behavioral Health State Contract (BHSC)

DBHR contract amendment for the period of July 1, 2017 through September 30, 2017, the maximum consideration has not been determined by the legislature.

Motions #1752-54 Provides the Executive Director the authority to sign state funded contracts once the Washington State Legislature has completed its biennial budget and the contracts are released for signature.

Motion #17-52

For Executive Committee Approval

Opioid Reduction Plan

In April, the draft “North Sound BHO Opioid Reduction Plan” was introduced to the Advisory Board and Executive Committee. Shelli Young, the consultant contracted by the North Sound BHO to develop the plan, provided a briefing to both groups. Following the instructions from the Executive Committee, the draft plan was distributed again to those stakeholders Shelli had interviewed for feedback. It was also presented and discussed with the Tribal “7.01 Committee” who requested that we meet individually with each Tribe and develop individual addendums summarizing the concerns of each tribe as well as the actions they would like to partner with the BHO on. The action items were also reviewed at the May 4 County Coordinators meeting, and the counties assigned the priorities identified in the attached plan. The North Sound BHO is also working with the North Sound Accountable Community of Health [NSACH] to align BHO funding for Opioid Reduction activities with NSACH funding. Once approved, the Plan will be posted on the BHO web site and the BHO will continue to work with the Counties, the ACH, Tribes, and others to continue to prioritize and implement the suggested strategies.

Motion #17-41

Approve the North Sound BHO Opioid Reduction Plan and direct BHO staff to continue to work with the Counties, the ACH, Tribes, and others to continue to prioritize and implement the suggested strategies.

Cammy moved the motion for approval, Geoffrey seconded, all in favor, Motion #17-41 carried.

Professional Service Contract

Catholic Community Services NW is receiving funding to remodel current Substance Use Disorder (SUD) Outpatient Facilities in Everett, Mount Vernon and Bellingham in the amount of \$125,000. Funding is also being provided for the continued development of their Electronic Health Record in the amount of \$477,900 inclusive of \$150,000 in equipment costs.

Motion #17-42

- North Sound BHO-CCSNW-PSC 17 for the purpose of expanding SUD Outpatient Facilities and the Electronic Health Record. The maximum amount on this contract is \$602,900 for a term of April 1, 2016 through December 31, 2017.

Geoffrey moved the motion for approval, Barbara LaBrash seconded, all in favor, Motion #17-42 carried.

Community Action of Skagit County

This amendment is providing an additional \$34,875 on this contract for a one-time expense of equipment needs/upgrades in the amount of \$9,850 and ongoing operational expense increase of \$1,925 monthly.

Motion #17-43

- North Sound BHO-CASC-Ombuds16-18 Amendment 1 for the purpose of increasing funding by \$34,875 for a new maximum consideration of \$370,875 with the term of contract remaining the same April 1, 2016 through March 31, 2018.

Barbara moved the motion for approval, Jackie seconded, all in favor, Motion #17-43 carried.

Budget Amendment

This motion is to transfer funds within the 2016 North Sound BHO operating budget. This will eliminate negative line item variances.

Motion #17- 44

- To approve the transfer of funds within the North Sound BHO 2016 Operating Budget.
 - Increase expenses of Machinery and Equipment by \$73,000
 - Increase expenses of Debt Service by \$227,000
 - Decrease expenses of Agency/County/Other services by \$300,000

Barbara moved the motion for approval, Regina seconded, all in favor, Motion #17-44 carried.

For Executive Committee Ratification

Professional Services Contract

Shelli Young (SYV Consulting) has been consulting with the North Sound on our Regional Opiate Plan, the plan is now complete and ready for implementation. Ms. Young will be assisting BHO staff and community partners on the implementation of the regional plan.

Motion #17-45

- North Sound BHO-SYV Consulting-PSC-17 Amendment 2 for the purpose of assisting in the implementation of the Regional Opiate Plan. This is an increase of \$75,000 for a new maximum consideration on this contract is \$94,900 with the term remaining the same, November 14, 2016 through December 31, 2017.

Discussion: the committee had those who approved and those who did not approve regarding this motion.

The Executive Committee would like the motion reviewed with the State Auditors in July.

Barbara moved the motion for approval, Regina seconded. 5 approved, 4 disapproved, motion passes 5 to 4 based on Article 7.6 Manner of Acting, page 14, Joint County Authority BHO Interlocal Operating Agreement of the North Sound Behavioral Health Organization, LLC.

Bill will clarify with the North Sound BHO Attorney and report at the next Executive Committee regarding increasing an existing Personal Services Contract over the \$25,000 threshold.

Mental Health Block Grant (MHBG)

This funding is specifically for the Peer Bridger Program at Western State Hospital. A Request for Proposals (RFP) was released in November 2017, with Telecare Corporation being the successful bidder. The Peers will be working with individuals being discharged from WSH to ensure they have a safe and seamless transition back to the community. The Peers can continue their engagement work for up to 90 days post discharge.

Motion #17-46

- DSHS-DBHR-North Sound BHO-MHBG-16-17 for the purpose of funding Peer Bridgers at Western State Hospital. The maximum consideration on this contract is \$240,000 with a term of July 1, 2016 through June 30, 2017.
- North Sound BHO-Telecare-MHBG-17 for the purpose of funding and developing the Peer Bridger Program at Western State Hospital. The maximum consideration on this contract is \$240,000 with a term of January 1, 2017 through June 30, 2017.

Cammy moved approval of the motion, Jackie seconded all in favor, Motion #17-46 carried.
